FACTS

WHAT DOES American National Bank Fox Cities (ANBFC) DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:

Social Security number and Payment history
 Account balances and Transaction or loss history
 Credit history and Checking account information

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share **customers**' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **customers**' personal information; the reasons **ANBFC** chooses to share; and whether you can limit this sharing.

What we do		
How does ANBFC protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We maintain procedural safeguards and restrict access to information, ensuring that only employees with appropriate authorization can access	
How does ANBFC collect my personal information?	We collect your personal information, for example, when you Open an account or Give us your contact information Make a wire transfer or Show us your driver's license Make deposits or withdrawals from your account We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.	
Why can't I limit all sharing?	 Federal law gives you the right to limit only sharing for affiliates' everyday business purposes—information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more information. 	
Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. American National Bank Fox Cities does not share with our affiliates.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. American National Bank Fox Cities does not share with nonaffiliate so they can market to you.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing includes credit card companies.	

Other important information

For Alaska, Illinois, Maryland and North Dakota Customers. We will not share personal information with nonaffiliates either for them to market to you or for joint marketing - without your authorization.

For California Customers. We will not share personal information with nonaffiliates either for them to market to you or for joint marketing - without your authorization. We will also limit our sharing of personal information about you with our affiliates to comply with all California privacy laws that apply to us.

For Massachusetts, Mississippi and New Jersey Customers. We will not share personal information from deposit or share relationships with nonaffiliates either for them to market to you or for joint marketing - without your authorization.
